BAWTRY TOWN COUNCIL (MARKET PLACE BAWTRY) OFF STREET PARKING PLACES ORDER 2021

Bawtry Town Council (hereinafter referred to as "the Council") in exercise of its powers under section 35 and section 57(1)(b) of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") as applied by section 59(3) of the Act with the consent of Doncaster Borough Council for the purposes of section 59(1) of the Act and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- 1 This Order shall come into operation on the \tag{7} day of \tag{2021} and may be cited as the Bawtry Town Council (Market Place Bawtry) Off Street Parking Places Order 2021.
 - 2 (1) In this Order: -

"The Act" means the Road Traffic Regulation Act 1984;

"Agent" means any contractor authorised and/or engaged by the Council to manage and operate the Parking Place and contact details will be notified to the public by signs displayed in a prominent position within the Parking Place

"Article" means an Article of the Order unless otherwise stated and includes reference to any paragraph of that Article referred to by number or letter;

"Bank Holiday" means a day which is or is observed as a bank holiday or a holiday under the Banking and Financial Dealings Act 1971 or any statutory re-enactment or modification for the time being in force;

"Annual Permit" means a parking permit purchased from the Council pursuant to the provisions of Articles 6(5), 6(6), 6(7), 6(8) and 6(9) of this Order and may be issued in either paper or electronic format;

"Charging Hours" means any period specified in column 5 of the First Schedule to this Order in respect of which a charge is specified in Article 6 to this Order;

"Council" means Bawtry Town Council;

"Disabled persons badge" as defined by the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"Disabled persons parking bay" means any area of a parking place that is provided for the use of disabled drivers for the parking of a Disabled person's vehicle and is indicated by symbols and or signage located within the boundaries of the parking bay;

"Disabled person's vehicle" has the same meaning as defined by the 1984 Act;

"Driver" in relation to a vehicle waiting in a parking place means the person driving the vehicle at the time it was left in the parking place or the person deemed to be the driver under the terms of this Orden;

"Electric Vehicle" means a Plug-in Electric Vehicle or a Plug-in Hybrid Electric Vehicle;

"Electric Vehicle Parking Bay" means an area of a parking place that is provided for the use of drivers of Electric Vehicles in order to recharge their vehicle by using the electric plug-in points in the car park and is indicated by blue lines, symbols and or signage located within the boundaries of the parking bay";

"Electric Vehicle Charging Point" means a purpose built unit designed specifically for the charging of electric vehicles;

"Evening Charging Hours" means any period specified in column 5 of the Second Schedule to this Order in respect of which a charge is specified in Article 6 to this order:

"Large Goods Vehicle" has the same meaning as defined in the Road Traffic Act 1988;

"Owner" in relation to a vehicle means the person by whom such vehicle is kept and used;

"Paragraph" means a paragraph or sub-paragraph of the Article in which the word appears;

"Parking Attendant" means a person authorised by or on behalf of the Council to supervise and control any parking place;

"Parking Bay" means any area of a parking place which is provided for the leaving of a vehicle and indicated by markings on the surface of the parking place;

"Parking Place" means any area of land specified by name in column 1 of the First. Second and Third Schedule to this Order provided by the Council under Section 57(1) of the 1984 Act for use as a parking place;

"Parking Ticket" means a ticket indicating the payment of a charge and the date and time at which the charge was paid:

"Permit" means an Annual Permit issued by the Council;

"Relevant position" means:

- (a) In the case of a vehicle fitted with a front windscreen the parking ticket, disabled persons badge or Annual Permit is exhibited thereon with the obverse side facing forwards on the nearside of and immediately behind the windscreen or as directed by the Council;
- (b) In the case of a vehicle not fitted with a front windscreen the parking ticket, disabled persons badge or Annual Permit is exhibited in a conspicuous position on the front or nearside of the vehicle or as directed by the Council;

"Schedule" means a schedule of this Order unless otherwise stated;

"Specified Parking Charge" is defined in Article 6 of this Order. Methods for payment of the Specified Parking Charge will be detailed on the Ticket Machine;

"Sunday Charging Hours" means any period specified in column 5 of the

Third Schedule to this Order in respect of which a charge is specified in Article 6 to this order

"Term Time Only" means the Doncaster Metropolitan Borough Councils academic year;

"Ticket Machine" for the purpose of this Order means an apparatus designed to issue parking tickets indicating the payment of a charge and the date and time at which the charge was paid. Methods for payment of the Specified Parking Charge will be detailed on the apparatus;

"Valid Ticket" " means a parking ticket which has not become invalid and is not being used in circumstances where it is not valid.

(2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament

USE OF LAND AND PARKING PLACE

- 3 (1) Each area of land specified by name in column 1 of the First, Second and Third Schedule to this Order may be used subject to the following provisions of this Order as a parking place for such classes of vehicles in such positions on such days and during such hours as are specified in relation to that area in the relevant Schedule
- Where in a Schedule to this Order a parking place is described as available for vehicles of a specified class or in a specified position the driver of a vehicle shall not permit it to wait in that parking place unless it is of the class and in the position so specified.
- Where within a parking place there is a sign or surface marking which indicates that a parking bay is available only for a disabled person's vehicle the driver of a vehicle shall not permit it to wait in that parking bay unless it is a disabled person's vehicle displaying a current disabled person's badge.
- 3 (4) The driver of a vehicle shall not permit it to wait in a parking place for longer than the maximum period permitted for waiting specified in Article 6 of this Order.
- 3 (5) Insofar as a vehicle is left in a parking place during either the charging hours period, the evening charging hours and/or the Sunday charging hours period the driver thereof shall pay such charge or charges as are specified in the following provisions of this Order.
- 3 (6) Any vehicle displaying an expired parking ticket or invalid permit shall not be left in a parking place.
- 3 (7) Nothing in sub paragraph 3(1) above shall restrict the power of the Council to close any parking place, parking bay or any part thereof at any time for such reasons as may be specified.
- 3 (8) The Council shall be entitled to suspend any or all of the provisions of this Order on such occasions and for such purposes as it thinks fit.
- Where within a parking place there is a sign or surface marking which indicates that a parking bay is available only for use by an Electric Vehicle the driver of a vehicle shall not permit it to wait in that parking bay unless it is an Electric Vehicle, the vehicle is being recharged at the Electric Vehicle

Charging Point contained within that parking bay and the specified parking charge is paid

EXEMPTIONS TO PAYMENT OF CHARGES

- 4 (1) Without prejudice to Article 5(2) of this Order the driver of a disabled persons vehicle which displays in a relevant position a disabled persons badge and is parked in a marked disabled parking bay shall be exempt from any payment specified in Articles 6(1) of this Order for a maximum period of 3 hours subject to the provisions of Article 18 of this Order.
- 4 (2) A vehicle which displays in the relevant position or as directed by the Council a valid Annual Permit that is left in a parking place specified in Article 6(6) shall be exempt from any payment specified in Article 6(1) of this Order.

CIRCUMSTANCES IN WHICH AN EXCESS CHARGE WILL BE PAYABLE

- 5 (1) If a vehicle is left in a parking place during the charging hours, the evening charging hours and/or the Sunday charging hours either:-
 - (i) without payment of the Specified Charge or Permit being made;
 - (ii) for a longer period than that for which a payment was made:
 - (iii) without a valid Parking Ticket or Permit being displayed;
 - (iv) if a vehicle other than a Disabled persons vehicle displaying a Disabled persons badge in the relevant position is parked in a parking bay marked as available only for a Disabled persons vehicle:
 - if the vehicle is left in a parking place other than wholly within a marked parking bay;
 - (vi) if the vehicle is a large goods vehicle;
 - (vii) if a vehicle, other than an Electric Vehicle, is left in a parking bay marked as available only for an Electric Vehicle.
- 5 (2) If a Disabled persons vehicle, displaying a Disabled persons badge in the relevant position, is left in a parking place other than in a marked Disabled persons parking bay then an excess charge shall be payable by the driver of the disabled persons vehicle.
- 5 (3) If an Electric Vehicle is parked in an Electric Vehicle Parking Bay without a valid Parking Ticket or Permit being displayed then an Excess Charge shall be payable by the driver of the Electric Vehicle.

AMOUNT OF SPECIFIED PARKING CHARGE AT PARKING PLACES

6 (1)

(i) The specified parking charge for a vehicle left in a parking place during the charging hours specified in First Schedule shall be: -

Market Place Bawtry £0.20 pence for a period not exceeding 30 minutes

£1.00 pence for a period exceeding 30 minutes but not exceeding 1 hour

£1.50 pence for a period exceeding 1 hour but not exceeding 2 hours

£2.00 pence for a period exceeding 2 hours but not exceeding 3 hours

£3.00 pence for a period exceeding 3 hours but not exceeding 4 hours

£6.00 pence for a period exceeding 4 hours but not exceeding 8 hours

With a maximum length of stay of 8 hours

Methods for payment of the Specified Parking Charge will be detailed on the Ticket Machine

Disabled Persons Badge Holders free for a maximum period of 3 hours in designated marked Disabled Persons Parking Bays only

6 (ii) The specified parking charge for a vehicle left in a parking place during the evening charging hours specified in Second Schedule shall be: -

Market Place Bawtry £0.00 pence for a period from 10 p.m. to 8 a.m. the following day

With a maximum length of stay of 10 hours

Methods for payment of the Specified Parking Charge will be detailed on the Ticket Machine

Disabled Persons Badge Holders free for a maximum period of 3 hours in designated marked Disabled Persons Parking Bays only

6 (iii) The specified parking charge for a vehicle left in a parking place during the Sunday charging hours specified in Third Schedule shall be: -

Market Place

£0.20 pence for a period not exceeding 30 minutes

£1.00 pence for a period exceeding 30 minutes but not exceeding 1 hour

£1.50 pence for a period exceeding 1 hour but not exceeding 2 hours

£2.00 pence for a period exceeding 2 hours but not exceeding 3 hours

£3.00 pence for a period exceeding 3 hours but not exceeding 4 hours

£6.00 pence for a period exceeding 4 hours but not exceeding 8 hours

With a maximum length of stay of 8 hours

Methods for payment of the Specified Parking Charge will be detailed on the Ticket Machine

Disabled Persons Badge Holders free for a maximum period of 3 hours in designated marked Disabled Persons Parking Bays only

- When a vehicle is left in a parking place the driver of a vehicle on parking shall purchase a parking ticket for the value of the specified parking charge fixed by this Order for the period of time the vehicle remains in the parking place. The driver of the vehicle shall follow the instructions detailed on the Ticket Machine as to the methods available for payment of the Specified Parking Charge. The parking ticket shall be displayed on the vehicle in respect of which it is issued in accordance with the provisions of Article 6(3) of this Order.
- (6) (3) A parking ticket should be attached to a vehicle in the relevant position and shall be kept in the relevant position until leaving the parking place. The parking ticket shall not be valid unless so displayed.
- 6 (4) A parking ticket issued at a parking place is not transferable between vehicles.
- 6 (5) The owner of a vehicle may on application to the Council purchase an Annual Permit in respect of that vehicle for a charge ascertained by reference to the scale of charges specified below and that Annual Permit shall be valid for the vehicle identified within the said application and any further amendment. The Annual Permit, if in paper format, shall be displayed on the vehicle in respect of which it is issued in the relevant position or as directed by the Council if in electronic format. Scale of charges:-
 - (i) £750.00 per year for an Annual Permit on a seven day basis
 - (ii) £620.00 per year for an Annual Permit on a five day basis
 - (iii) £540.00 per year for an Annual Permit on a five day basis Monday to Friday (Term Time Only)
 - (iv) £560.00 per year for an Annual Permit on a four day basis
 - (v) £430.00 per year for an Annual Permit on a three day basis
 - (vi) £280.00 per year for an Annual Permit on a two day basis
 - (vii) £140.00 per year for an Annual Permit on a one day basis
- 6 (6) Any Annual Permit applied for under the provisions of Article 6(5) of this Order may be used for parking on:-
 - (i) Market Place Bawtry

- 6 (7) The Council may require an applicant for any permit to produce such evidence in respect of the application as may reasonably be required to verify any particulars or information given.
 - (i) Any permit may be surrendered to the Council at any time and must be surrendered to the Council on the occurrence of any of the events set out in paragraph (iii) of this Article.
 - (ii) The Council may by notice in writing served on any permit holder at the address shown by that person on the application for any permit or at any other address considered appropriate by the Council withdraw a permit if it appears to the Council that any of the events set out in paragraph (iii) of this Article have occurred and any permit shall be surrendered to the Council within 48 hours of the receipt of the said notice.
 - (iii) the events referred to in the foregoing provisions of this Article are:-
 - the permit holder causing or permitting the permit to be used for reward;
 - (b) if in the opinion of the Council the use of the permit is being abused;
 - (c) the issue of a duplicate permit by the Council under the provisions of Article 6(8)(i) or (ii) of this Order.
 - (iv) Any permit shall cease to be valid on the occurrence of any of the events set out in paragraph (iii) above
- 6 (8) (i) If any permit is mutilated or defaced or the particulars on it have become illegible or it has become altered by fading or otherwise the permit holder shall surrender it to the Council and may then apply to the Council for the issue of a duplicate permit.
 - (ii) If a permit is lost or destroyed the holder may apply to the Council for the issue of a duplicate permit.
 - (iii) The provisions of this Order shall apply to a duplicate permit and an application for such permit as if it were a permit or as the case may be an application for any permit.
 - (iv) The issue of a duplicate permit by virtue of the provisions of paragraph (i) or (ii) of this Article shall render the original permit invalid.
 - (v) The permit holder will have their permit revoked by the council for non-payment of the permit charge.
 - (vi) The Council may withdraw any permit after providing the permit holder with a notice period of ten (10) working days informing of its intention to withdraw the permit and that notice period shall run from the date specified on said notice.
- 6 (9) If the permit holder applies to the Council for a duplicate permit then the permit holder shall be liable to a charge of £10

REFUND OF CHARGE IN CONNECTION WITH THE ISSUE OF ANY PERMIT

- 6 (10) (i) A permit holder who surrenders to the Council any permit before the permit becomes valid shall, provided that they have given to the Council a notice of ten (10) working days, be entitled to a refund of any charge paid in respect of the issue thereof
 - (ii) A permit holder who surrenders a permit to the Council after the permit has become valid shall, provided that they have given to the Council a notice of ten (10) working days, be entitled to a refund of that part of the charge paid in respect of the issue of the permit as is attributable to the period from receipt by the Council of the surrendered permit to the expiry of the period for which the permit was issued

AMOUNT OF EXCESS CHARGE AT PARKING PLACES

- (1) Subject to the provisions of Article 5, 17,18 and 19 of this Order in relation to a vehicle waiting in a parking place the amount of excess payable will be the specified parking charge together with an additional amount of £50.00 (which additional amount is hereinafter referred to as the "excess charge") and shall be payable by the owner of the vehicle PROVIDED THAT if within 14 days following the date notice of such excess charge is issued as provided in this Article the owner of the vehicle tenders the sum of £25 then such latter sum may be accepted by the Council or its Agent in satisfaction of the excess charge
- 7 (2) In the case of a vehicle in respect of which an excess charge may have been incurred it shall be the duty of a parking attendant to attach to the vehicle in a conspicuous position a Notice which shall include the following particulars:-
 - (i) The registration mark of the vehicle or where the vehicle is being used under a trade licence the number of the trade plate carried by the vehicle
 - (ii) The make model and colour of the vehicle
 - (iii) The name of the parking place in which the vehicle is left and the date and time of the attaching to the vehicle of the said notice
 - (iv) The details of the offence for which the excess charge notice has been issued or alternatively a statement to the effect that no valid parking ticket was displayed
 - (v) The manner in which and the time within which the excess charge should be paid
 - (vi) A statement that the excess charge of £50.00 is required to be paid and that a sum of £25.00 may be accepted by the Council or its Agent in satisfaction of the excess charge if payment is made within 14 days of the date of the notice and
 - (vii) A statement that it is an offence under section 35(A) of the Act for the driver of a vehicle who has left the vehicle in a parking place to fail to pay the excess charge

RESTRICTION OF REMOVAL OF NOTICES

When a Notice has been attached to a vehicle in accordance with any of the foregoing provisions of this Order no person other than a person authorised by the Council in that behalf or the driver or a person authorised by the driver in that behalf shall remove the Notice from the vehicle

OTHER PROVISIONS

- 9 Pursuant to powers given for the purpose in Sections 35(A) of the 1984 Act the following shall apply:-
 - (i) if on the date a vehicle is left in a parking place a person is shown to have been the Registered Owner or Keeper thereof in writing from the Vehicle Registration Authority then for the purpose of this Order and any legal proceedings in relation thereto it shall be conclusively presumed (notwithstanding that such a person may not be an individual) that he was the driver of the vehicle at that time and accordingly that acts or omissions of the driver of the vehicle at that time were his acts or omissions unless the Registered Keeper can prove that at the relevant time the vehicle was in the possession of some other person without his consent or that he was not the owner of the vehicle
 - (ii) the date and time printed on any parking ticket from a ticket machine at a parking place shall be good evidence in any legal proceedings in relation to this Order that the parking ticket was purchased on that date and at that time
 - (iii) where in any legal proceedings in relation to the failure to pay any charge under this Order it is proved to the satisfaction of the Court that the amount which has become due or any part thereof has not been paid the Court shall order the payment of the sum not paid which shall then become recoverable as a penalty
- 10. The driver of a vehicle shall not permit that vehicle to wait in a parking place unless the vehicle is licensed in pursuance of the provisions of the Vehicle Excise and Registration Act 1994 or other statutory re-enactment and there is in place in relation to the use of the vehicle by the driver such policy of insurance as complies with the requirements of Part VI of the Road Traffic Act 1988 or other statutory re-enactment
- The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place
- 12 (1) No person shall use a vehicle while it is in a parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services
- 12 (2) No person shall use any part of a parking place or any vehicle left in a parking place -
 - (i) for sleeping or camping or cooking or
 - (ii) for the purpose of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place

- 13. The driver of a vehicle using a parking place shall not sound any horn or other similar instrument except when about to change the position of the vehicle in or to depart from the parking place
- 14 (1) If a vehicle is left in a parking place in a position other than in accordance with the provisions of Article 3 of this Order a person authorised by the Council in that behalf may alter or cause to be altered the position of the vehicle so that its position is in accordance with the said provisions
- 14 (2) For the purpose of meeting the requirements of an emergency a police constable in uniform may alter or cause to be altered the position of a vehicle in a parking place or remove or arrange for the removal of a vehicle from a parking place
- 14 (3) Any person altering or causing the alteration of the position of a vehicle or removing or causing the removal of a vehicle may do so by towing or driving the vehicle or in such other manner as he may think reasonably necessary to enable the position of the vehicle to be altered or the vehicle to be removed
- 14 (4) Any person removing or arranging for the removal of a vehicle shall make such arrangements as he considers to be reasonably necessary for the safety of the vehicle in the place to which it is removed
- Where in a parking place signs are erected or surface markings are laid for the purpose of: -
 - (i) indicating the entrance to or exit from the parking place or
 - (ii) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place

No person shall drive or permit to be driven any vehicle (i) so that it enters the parking place otherwise than by an entrance or leaves the parking place otherwise than by an exit so indicated or (ii) in a direction other than so specified

- No person shall except with the permission of a person authorised by the Council in that behalf drive or permit to be driven any vehicle in a parking place for any purpose other than the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place
- Where, in the parking place, signs are erected or surface markings are laid for the purpose of indicating disabled person's parking bays, and the driver of a disabled person's vehicle, which is displaying a current disabled person's badge, parks the said vehicle in one of the said bays provided for not longer than a maximum period of 3 hours shall be exempt from any payments specified in Articles 6 and 7 of this Order
- A disabled persons vehicle which is parked in a parking bay other than a marked disabled person's parking bay shall not be exempt from any payment specified in Articles 6 and 7 of this Order.
- Where in the parking place signs are erected or surface markings are laid for the purpose of indicating motor cycle bays the rider of a motor cycle shall park in one of the bays provided for a maximum length of stay specified in Article 6 of this Order for that car park and shall be exempt from any payment in the bays provided as specified in Articles 6 and 7 of this Order

- No vehicle shall be left in a parking place other than in a position indicated by a sign or by white lines on the surface of the parking place and in particular no vehicle shall be left in a parking place in such a position so as to obstruct the entrance thereto or the exit there from nor in such a position so as to prevent the driving away of any vehicle already in a parking place or in such a position so as to cause an obstruction to other vehicles
- The Council may suspend the operation of this Order or any provision of the Order on any day at any time when any area of land specified in column 1 of the First, Second and/or Third Schedule to this Order is required in connection with any official function or business of the Council or on account of any security reasons or for any other purpose whatsoever
- No person shall in any parking place wantonly shout or otherwise make any loud noise to the disturbance or annoyance of users of the parking place or residents of premises in the neighbourhood
- No person shall in any parking place use threatening abusive or insulting language gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned
- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment.
- 25 The Order shown in the Fourth Schedule to this Order is hereby revoked
